- 6. At 3:04pm Discussion began over approving the monthly expenses. Mr. Wadley made the motion to approve the engagement letter. The motion was seconded by Mr. Poteet. Unanimous approval was given.
- 7. At 3:08pm Discussion began over approving the engagement letter with Angel, Johnson, and Blasingame for FY 22-23 Audit. Mr. Clanton made the motion to approve the engagement letter. The motion was seconded by Ms. Kennedy. Unanimous approval was given.
- 8. At 3:08pm Discussion began over approving the 23-24 fiscal year budget. Mr. Wadley made the motion to approve the budget. The motion was seconded by Mr. Poteet. Unanimous approval was given.
- 9. At 3:13pm Discussion began regarding approving the payment to Stolz Telecom for the maintenance agreement for the radio system in the amount of \$12,496.51. Mr. Poteet made the motion to accept the payment. The motion was seconded by Ms. Kennedy. Unanimous approval was given.
- 10. At 3:13pm Discussion began regarding approving the quote from Stolz Telecom for radios for the new truck in the amount of \$8,046.20. No action was taken. Item tabled for next meeting.
